APPLICATION FOR MEMBERSHIP and AGREEMENT FOR ELECTRIC SERVICE

The undersigned hereby applies for membership in Altamaha Electric Membership Corporation and to the end agrees as follows:

1. To pay the sum of \$ _____ as a membership fee plus a service security deposit of \$ _____.
2. To pay the sum of \$ _____ as an additional service security deposit.
3. To pay the sum of \$ _____ as a non-refundable establishment fee.
4. To purchase from the Cooperative all central station electric power and energy used on any and all premises to which the Cooperative furnishes electric service pursuant to membership for so long as such premises are owned or directly occupied or used by the Member.
5. The member will pay the Cooperative's billings for service hereunder at the Cooperative's office monthly and within 15 days after such bill is mailed to the Member, failing which the Cooperative may discontinue service hereunder without further notice; but discontinuance due to Member's failure to fulfill this or any other requirement herein called for shall in no way relieve the Member of his obligations or liabilities hereunder. The Member will keep the Cooperative informed of Member's correct current mailing address.
6. To be bound by and to comply with all of the other provisions of the Cooperative's certificate of incorporation and bylaws, and all rules, regulations and rate schedules established pursuant thereto, as all the same now exists or may hereafter be adopted or amended, and with the provisions of any supplemental contract that may, coincide herewith, be executed by me with the Cooperative.
7. It is also understood and agreed that membership fees and service security deposits are not transferable.
8. It is also understood and agreed that, after any termination of membership, the undersigned Applicant will be refunded his or her membership fee and service security deposit without interest provided it is not needed to cover the electric bill.
9. The Cooperative shall use reasonable diligence to provide a constant and uninterrupted supply of electric power and energy, but if such supply shall fail or be interrupted, or become defective, through act of God or the public enemy, or by accident, strikes or labor trouble, or by action of the elements, or because of inability to secure right-of-way or other permits needed, or for any cause beyond reasonable control of the Cooperative, the Cooperative shall not be liable therefore. The Member grants the Cooperative permission to enter upon the property for the purpose of inspecting and maintaining the electric distribution system, trimming right-of-way and reading of the meter in order that the Cooperative may reasonably fulfill its obligation of providing a constant and uninterrupted supply of electric power. It is the Member's responsibility to have the premises adequately wired with the correct size wire and shall have all electric equipment adequately protected with overcurrent devices as required by the latest edition of the National Electrical Code.
