

- Heat pumps account for approximately 52 percent of a home's energy use
- Have your system serviced by a licensed contractor at least once annually, typically in the spring or fall
- Change filter out according to size of filter (one-inch, monthly; five-inch, twice a year)
- Keep supply vents and return vents clear of obstruction for more efficient air flow
- Have ductwork checked periodically for leaks and proper air flow

THERMOSTAT

- Keep thermostats set at 68 degrees in winter and 78 degrees in the summer
- Energy use increases an average of 3 percent to 5 percent for each degree change
- Consider utilizing a Wi-Fi thermostat to regulate temperature changes (no more than 2 degrees at a time) to prevent heat strips from coming on causing a greater consumption of power

WEATHER STRIPPING/CAULKING THRESHOLD

- Check exterior door seals and thresholds periodically for air infiltration and change when needed
- Check windows for air infiltration and caulk and seal where needed
- Seal around all exterior plumbing fixtures to minimize air infiltration

WATER HEATER

- Water heaters account for approximately 18 percent of a home's energy use
 - Ensure thermostat temperature is set at 120 degrees on both top and bottom thermostats
 - Drain and refill annually to rid tank of sediments
 - Have your water heater serviced annually by a licensed plumber

LIGHTS

- Lighting accounts for about 9 percent of a home's energy use
 - Utilize LED lighting to have better quality lighting while reducing power consumption
 - Conversions:

6-7 watt LED bulb is equivalent to a 40-watt incandescent bulb 7-10 watt LED bulb is equivalent to a 60-watt incandescent bulb 12-13 watt LED bulb is equivalent to a 70-watt incandescent bulb

14-20 watt LED bulb is equivalent to a 100-watt incandescent bulb




Burn Foundation of America\$ 5,000.00

The Burn Foundation of America

was awarded a \$5,000 grant to provide medical supplies and assistance to burn victims and their families. The Burn Foundation supports families of patients treated at the Joseph M. Still Burn Center in Augusta. In 2018, they assisted 2,177 families, 93 of those families live in Altamaha EMC's service area.

Toombs County Extension/4-H was awarded a \$3,000 grant to help fund youth leadership projects.

Broadband Progress Update

Altamaha EMC's grant application was not approved during the first round of USDA's ReConnect Program. None of the EMCs in Georgia were recipients of funds during this first round. This is very disappointing considering the need we have in rural Georgia.

We were rejected because maps used by USDA show certain locations in our proposed service area as already having adequate broadband service. We know it's not the case, but until USDA revises their maps to better show actual coverage we have to play by their rules. These maps are being revised but currently they favor the existing traditional broadband providers.

The good news is that there is a second round of funding and we are working diligently to submit our applications before the March deadline. We remain committed to bring broadband service to our members. Our application will propose starting the broadband service in areas that unquestionably qualify for the grant money and use that as the backbone for expansion to eventually reach every cooperative member. We need the grant as seed money to ensure a successful startup. Legislation prohibits EMCs from using any money from the electric side of the business to subsidize the broadband services.

We will need the help of our members as we prepare this new application. If asked, please respond to help us better meet your critical needs for the future.



Foundation Scholarship Applications Available

Four scholarships, worth \$500 each, will be awarded to local students this spring. The Altamaha EMC Foundation Scholarships were founded in an effort to help local students further their education. The scholarships are funded entirely by members' donations through Operation Round

Up. Applicants must be a high school senior and live in the household of an Altamaha EMC member.




everything from shutting off power to your home to legal action. Don't fall victim to these types of scams.

Chicken Veggie Rice

Ingredients:

1 tablespoon vegetable oil

1 pound boneless, skinless chicken breast, cut into small pieces

1 teaspoon garlic-herb seasoning (salt-free)

1/2 teaspoon black pepper

1/4 teaspoon red pepper flakes

1 small onion, thinly sliced

1 (10.5-ounce) can reduced-sodium chicken broth

1/4 cup water

1-1/2 cups instant brown rice, uncooked

1-1/2 cups grape tomatoes, halved

4 cups baby spinach leaves, washed, patted dry

Directions:

Heat oil in large skillet over medium heat. Sprinkle chicken pieces with seasonings. Add chicken pieces; cover and cook about 10 minutes, stirring frequently until chicken is done. Add onion and stir-fry for about 1 minutes. Stir in broth, water, rice, tomatoes and spinach. Bring to a boil. Reduce heat to low and cover. Simmer about 10 minutes. Turn burner off and let stand for 5 more minutes or until rice absorbs most of the liquid. *Serves 4*.
